Subject: **ANNUAL PROCUREMENT PLAN UPLOADING ON PPRA WEBSITE.**

PPRA has been frequently approached by the public sector organizations for uploading their procurement plan which could not be accomplished due to several reasons regarding approval of budget and COVID-19. Therefore, in order to facilitate all procuring agencies two time dispensation was already given to all Procuring Agencies through this office letters Nos. L&M (PPRA)10-1/2011/kw dated 30th July, 2020 & MD(PPRA) 10-1/19/APP dated 07th September, 2020 for uploading the procurement plan on PPRA site.

Recently a number of Procuring Agencies have once again approached PPRA with the excuses of non-uploading of Annual Procurement Plan despite of

forementioned dispensation. PPRA, in order to facilitate all, is extending the Annual Procurement Plan uploading upto 31-03-2021. All that have not uploaded their Annual Procurement Plan yet may avail this dispensation, failing which the procuring agency plan will not be accepted by the system which is being modified for the time being as per latest cutoff date.

It is to be noted that in future no such dispensation will be given in this financial year i.e. 2020-21, for equity aids the vigilant and not the indolent. Since in terms of Rule 8 & 9 of PPRA Rules 2014, all procurements are to be made in accordance with the procurement plan and in terms of Rule 69 of rules ibid any violation of PPRA Rules is treated as mis procurement hence it is requested that compliance of PPRA rules (8&9) may please vigilantly be accomplished to avoid any legal repercussion or evasion of respective law. Govt. powers must be exercised within the constraint of rules whatever they may be, must be uniformly applied (PLD 2009 SC 879).
