**NOTIFICATION**

**No.SO(Cab-I)2-9/2015.-** In exercise of the powers conferred under section 26 of the Punjab Procurement Regulatory Authority Act 2009 (*VIII of 2009*), Governor of the Punjab is pleased to make the following amendments in the Punjab Procurement Rules 2014, with immediate effect:

**AMENDMENTS**

**In the Punjab Procurement Rules 2014:**

1. In rule 12, after sub-rule (1), the following shall be inserted:

"(2) Subject to rule 13, any procurement exceeding five million rupees shall be advertised on the website of the Authority, the website of the procuring agency, if any, and in at least two national daily newspapers of wide circulation, one in English and one in Urdu."

2. In rule 14, for sub-rule (3), the following shall be substituted:

"(3) The response time shall be calculated from the date of publication of the advertisement on the website of the Authority:

Provided that in case of publication of the advertisement in newspaper, Uniform Resource Locator (URL) of the website of the Authority shall be expressly mentioned in such advertisement specifying that the response time shall be calculated exclusively from the date of publication of such advertisement on the website of the Authority."
